

# Melville Douglas STANLIB Balanced Fund

## What is the fund's objective?

The objective of the fund is to deliver high growth of capital and income, a reasonable level of current income and relative stability for capital invested to obtain long term wealth accumulation.

## What does the fund invest in?

The fund is an actively managed multi-asset class mandate designed to reflect Melville Douglas's optimal long-term capital growth strategy. The fund focuses on delivering balance between investment returns and the risk associated with those returns, between capital growth and cash generation and balance between compound and cyclical price performers. The maximum equity effective exposure (including international equity) will not exceed 75% of the market value of the portfolio.

## What possible risks are associated with this fund?

General market risks include a decline in property values, share price volatility, a change in interest rates and economic conditions. Where foreign securities are included in the portfolio there may be additional risks, such as potential constraints on liquidity and the repatriation of funds, macro-economic risks, political risks, tax risks, settlement risks, and potential limitations on the availability of market information.

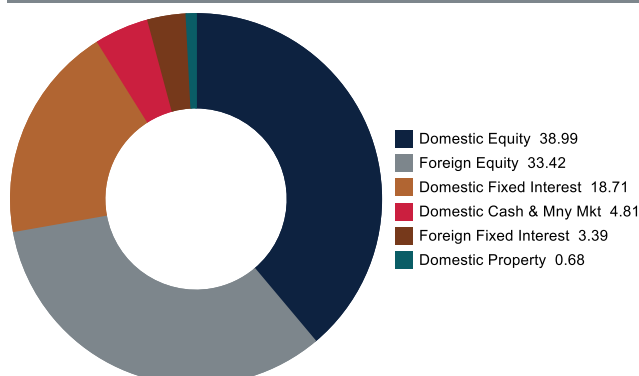

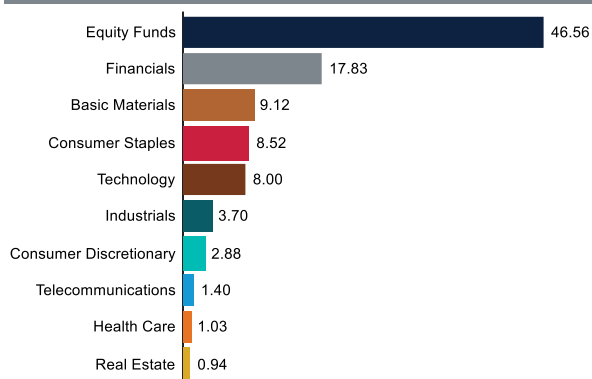
### Asset allocation (%)



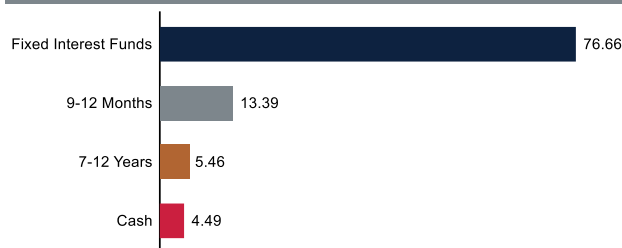

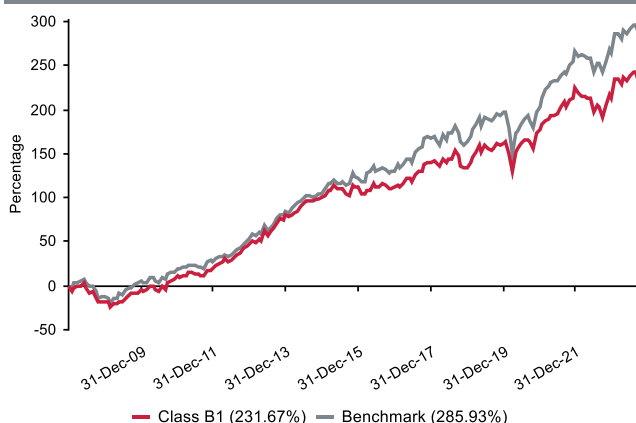

## Fund review

The Fund delivered a return of -2.3% in 3Q23, behind the benchmark return of -1.5%. The 1-year return of 14.2% outperformed the benchmark of 13.0%. In September, from a currency perspective, the US Dollar strengthened as the currency benefited from a widening in interest rate and growth differentials. For the quarter, the Rand was down 0.4%. The Domestic equity fund (-1.4%) outperformed the benchmark (-3.8%) and peer group (-2.8%). The MD Global Equity Fund returned -4.7% versus the benchmark of -3.4% (in USD terms) for 3Q23. In South Africa, the best performing sector for the 3Q23 was Industrials (6.1%) followed by Financials (4.5%) and Consumer Staples (2.0%). The Fund's best performing stocks were OUTsurance (25.7%), Sasol (16.7%), and Sanlam (12.5%). The resource counters (Anglogold (-23.2%) and Impala (-19.8%)) remained under pressure as the slower than expected Chinese rebound, reduced the demand for commodities. Richemont (-26.2%), one of the most exposed names to China within the luxury sector felt the brunt of the pain as consensus estimates were revised down given the short-term negative earnings momentum, driven by a continued weakened Chinese macro. For the quarter, bonds were down -0.8% vs the benchmark of -0.3%.

## Market overview

The Global equity market has lost some of its shine from the initial surge in equity prices during the first half of the year. While the US economy appears to be on a different growth trajectory to the rest of the world, softening economic data, particularly in Europe and China, has led to growing concerns about the near-term growth outlook. Earnings revisions have turned negative and the outlook for interest rates has become even more restrictive, with interest rates set to remain higher for longer. Inflation levels seem to have peaked across the Globe and are deemed to be sticky at these elevated levels, leaving Central banks cautious on their approach to policy rates.

During the third quarter of the year, the MSCI ACWI and JPM Global Aggregate Bond Index were both down -3.4 and -3.5% respectively. Investors were discouraged by interest rates remaining higher for longer, with bond yields reaching their highest level of this current cycle, which caused equity prices adjusting lower to a higher discount rate. The South African equity market was not spared the sell-off in Global markets, with the FTSE/JSE Capped SWIX returning -3.8%.

## Looking ahead

Despite the numerous headwinds facing the South African economy, namely a failing infrastructure system, lack of service delivery, persistently high inflation, inflated interest rates, and the volatile currency, we do believe that the negative news flow is already discounted in share prices, even after adjusting for a higher cost of equity. In this structurally challenging environment, we expect volatility to persist in the near term until interest rates have peaked and/or global growth concerns stabilise. We believe the SARB will hold rates steady at current levels for longer than was previously expected. This investment environment requires caution, and our strategy remains to be invested in high quality businesses with strong balance sheets and robust cash flow streams.
